BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Wilson Engineering, for as-needed civil engineering services for the City of San Diego Water Utilities Department, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 281860.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$250,000.00, consisting of \$125,000.00 from Water Revenue Fund 41500, Water Engineering Program (70830), and \$125,000.00 from Sewer Revenue Fund 41506, Sewer Engineering Program (70820), is hereby authorized, solely and exclusively for the purpose of providing funds for the above agreement, with actual expenditures accounted for in the specific projects (including CIP) on which work is performed.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.


