WHEREAS, on August 3, 1992, the Council of The City of San Diego agreed, with approval, that the City of San Diego should conduct a Disparity Study to review and evaluate the history of the Equal Opportunity Contracting Program; and

WHEREAS, on August 3, 1992, the Council of The City of San Diego also approved the formation of the MBE/WBE Program Review Task Force to review the history and evaluate the success or failure of the Equal Opportunity Contracting Program as currently constructed and to assist in the formulation of scope of work parameters for the Disparity Study; and

WHEREAS, the Equal Opportunity Contracting Program in conjunction with the MBE/WBE Program Review Task Force has formulated a Request For Proposals for the Disparity Study; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager's recommendation on the Disparity Study, as set forth in the attached Report to the Honorable Mayor and City Council on said subject, be and the same is hereby accepted.

BE IT FURTHER RESOLVED, that the City Manager is directed to identify a funding source for the Disparity Study.
