A RESOLUTION APPROVING WAIVER OF PAYMENT IN LIEU OF TAXES (PILOT) PAYMENTS FOR FISCAL YEAR 1993 AND FISCAL YEAR 1994

WHEREAS, the Housing Authority of The City of San Diego ("Local Authority") has entered into an agreement with the City of San Diego committing the City to provide the same services to conventional housing units that would be provided to a private residential development; and

WHEREAS, the purpose of the Payment in Lieu of Taxes (PILOT) payment is to reimburse the City of San Diego for cost of services traditionally covered by real property taxes; and


WHEREAS, the Housing Authority has expended monies for services usually provided by the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the PILOT payments for Fiscal Year 1993 and Fiscal Year 1994 be waived.

BE IT FURTHER RESOLVED, that the City Council will consider a future extension of the PILOT payment waiver based upon circumstances which may exist with respect to Fiscal Year 1995 and subsequent years.
