WHEREAS, the Council proposes to approve an Owner
Participation Agreement (the "Agreement) with the AFJR
Partnership (the "Owner") for the rehabilitation of a commercial development and possible public restroom facilities (and lease of such public restroom facilities to the City) on certain real property in the Project area; and

WHEREAS, the rehabilitation of the commercial development and possible public restroom facilities (and lease thereof to the City) on the real property pursuant to the provisions of the proposed Agreement between the Agency and the Owner is a redevelopment implementation activity whose environmental impacts are assessed in the MEIR; and

WHEREAS, the Centre City Development Corporation, Inc., acting on behalf of the Agency, has prepared a Secondary Study in accordance with and pursuant to the California Environmental Quality Act of 1970 (CEQA) and state and local regulations and guidelines adopted pursuant thereto and such Secondary Study assesses the environmental impacts of the rehabilitation of the real property pursuant to the Agreement; and

WHEREAS, the Council has considered the environmental effects of the proposed rehabilitation as shown in the MEIR and the Secondary Study; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the Council hereby certifies that the Secondary Study of environmental impacts with respect to the proposed rehabilitation of the real property pursuant to the Agreement has been prepared and completed in compliance with the California Environmental Quality Act of 1970 (CEQA) and state and local regulations and guidelines adopted pursuant thereto.
- 2. That the Council hereby further certifies that the information contained in the Secondary Study and the MEIR has been reviewed and considered by the members of the Council.

- 3. That the Council hereby finds and determines that:
- a. No substantial changes are proposed in the Centre City Redevelopment Project, or with respect to the circumstances under which the Project is to be undertaken, as a result of the rehabilitation of real property (and lease of the public restroom facilities to the City) pursuant to the Agreement, which will require important revisions in the MEIR for the Project, due to the involvement of new significant environmental impacts not covered in the MEIR; and
- b. No new information of substantial importance to the Project has become available which was not known or could not have been known at the time the MEIR for the Project was certified as complete, and which shows that the Project will have any significant effects not discussed previously in the MEIR, or that any significant effects previously examined will be substantially more severe than shown in the MEIR, or that any mitigation measures or alternatives previously found not to be feasible or not previously considered would substantially reduce or lessen any significant effects of the Project on the environment; and
- c. No negative declaration, or subsequent environmental impact report, or supplement or addendum to the MEIR is necessary or required; and
- d. The rehabilitation of the real property (and lease of the public restroom facilities to the City) pursuant to the Agreement will have no significant effect on the

environment except as identified and considered in the MEIR for the Project.
