W.O. 119954, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MODERNIZATION/MODIFICATION OF TRAFFIC SIGNALS AND STREET LIGHTING AT 25TH STREET AND BROADWAY, 25TH STREET AND "C" STREET, 30TH STREET AND BROADWAY, 30TH STREET AND "C" STREET AND AT CATALINA BOULEVARD AND VOLTAIRE STREET.

BE IT FURTHER RESOLVED, that the expenditure of \$300,000.00 from CIP No. 62-290.0, \$240,000.00 from Fund 79501, \$60,000.00 from Fund 79508, Modify/Modernize Traffic Signals - DIF Funded, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to retain excess budgeted funds, if any, in appropriate fund.
