WHEREAS, the sale of such an interest in real property as this may reasonably be accomplished by negotiation; and


WHEREAS, the value of the property is the cost of processing the documents; and

4. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed and a certified copy of this resolution to the Engineering and Development Department for further handling.
