RESOLUTION NUMBER R- 281689

ADOPTED ON MAR 29 1993

WHEREAS, The City of San Diego is the owner of portions of Lot A, Penasquitos Park View Estates, Unit No. 3, and Lot A, Penasquitos Park View Estates Unit No. 2; and

WHEREAS, the City desires to negotiate the sale of said land to the STATE OF CALIFORNIA, under the provisions of Section 22.0902 of the San Diego Municipal Code which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City, as determined by CalTrans appraiser on November 15, 1990, is \$2,000; and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That certain real property described in those grant deeds on file in the office of the City Clerk as Document Nos.

RR- 281689-1 and RR- 281689-2, be, and the same is hereby authorized to be sold by negotiation for the amount of \$2,000 to the STATE OF CALIFORNIA.

2. That the City Manager or his designee is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, grant deeds, copies of which are on file in the office of the City Clerk as Document Nos. RR- 281689-1 and RR- 281689-2, granting to the STATE OF CALIFORNIA all those portions of Lot A, Penasquitos Park View Estates, Unit 3, and Lot A, Penasquitos Park View Estates, Unit 2, as more particularly described in the grant deeds.



That the City Manager or his designee is hereby authorized to execute, for and on behalf of The City of San Diego, two Right of Way Contracts with the STATE OF CALIFORNIA in connection with the sale of the above described property, copies of which Right of Way Contracts are on file in the office of the City Clerk as Document Nos. RR- 281689-3 and RR- 281689-4

4. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

5. That the City Clerk is hereby authorized and directed to deliver the documents and a certified copy of this resolution, attested by him under seal, to the Property Department for further handling.
