BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to direct the Park and Recreation Department, Special Projects Office, to coordinate City Forces and implement construction of temporary lighting within Balboa Park, pursuant to the Feasibility Study dated January 28, 1993 prepared for the Public Facilities and Recreation Committee, with the cost of said work not to exceed \$50,000.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$50,000 from San Diego Facilities and Equipment Leasing Corporation Construction Fund 91101, CIP No. 21-834.0, is hereby authorized, solely and exclusively to fund the above project.
