

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$23,000 from CIP No. 29-797.0, Marcy Park Tot Lot, is hereby authorized, solely and exclusively to supplement funds previously authorized for purchases by Resolution No. R-281042.

BE IT FURTHER RESOLVED, that for an on behalf of the citizens of San Diego, the Council hereby thanks the Friends of Marcy Park for their generous donations of funds and equipment.
