RESOLUTION NUMBER R- 281695

ADOPTED ON MAR 29 1993

WHEREAS, the City's Traffic Engineering section has conducted traffic and engineering studies on Manning Way, Stonepine Lane, Pinecone Lane, Camphore Lane and Coast Boulevard; and

WHEREAS, based upon traffic and engineering studies a City is authorized under California Vehicle Code section 22358.3 to lower the prima facie speed limit on certain qualifying streets; and


WHEREAS, the City Manager has recommended and the traffic and engineering studies support 15 miles per hour speed limits on Manning Way, Stonepine Lane, Pinecone Lane, Camphore Lane and Coast Boulevard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to establish a posted speed limit of 15 miles per hour on the following roadways: Manning Way, from Palm Avenue to 250 feet south; Stonepine Lane, entire length; Pinecone Lane, entire length; Camphore Lane, entire length, and Coast Boulevard, from Girard Avenue to Coast Boulevard South.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized

to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
