ADOPTED ON MAR 29 1993

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with the San Diego Society of Natural History (also called the Museum of Natural History), to reimburse the museum for costs of upgrading the facility, heating, ventilating and air conditioning the building and upgrading the seismic resistance of the structure, under the terms and conditions set forth in the Reimbursement Agreement on file in the office of the City Clerk as Document No. RR- 281699, as well as any reasonably necessary modifications or amendments thereto which do not increase the above projects' scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of the projects and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$489,922 from San Diego Facility and Equipment Leasing Construction Fund 91101, is hereby authorized, solely and exclusively to reimburse the museum for the above costs.
