
RESOLUTION NUMBER R- 281700

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute, for and on behalf of The City of San Diego, a one-year lease agreement, with four one-year extensions, with MISSION FEDERAL CREDIT UNION, for 1,000 square feet of office space at 4434 Ingraham Street, for use by the Police Department as a Community Relations Office, at an initial monthly rent of \$800, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 281700 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,454 from Fund 100, Department 110, Organization 485, Object Account 4682, Job Order 1114, to cover costs for the period March 29, 1993, to June 30, 1993, is hereby authorized and approved.
