RESOLUTION NUMBER R-281716

ADOPTED ON MARCH 30, 1993

WHEREAS, Roman Catholic Bishop of San Diego, Owner/Permittee, filed an application to amend a conditional use permit to construct, operate and convert an existing 80,000 square-foot chapel and convent to use as a Pastoral Center for the Roman Catholic Diocese of San Diego located at 3889 Paducah, described as Villa Marina, Unit #1, Lots 1-11 (Record of Survey 6224, Division Plat 73, Subdivision 4550), in the Clairemont Community Plan Area, in the R1-5000 zone; and

WHEREAS, on January 7, 1993, the Planning Commission of The City of San Diego considered and denied Conditional Use Permit No. 92-0315 amending Conditional Use Permit No. C-4655, pursuant to Section 101.0510 of the San Diego Municipal Code; and

WHEREAS, the Owner/Permittee has appealed said Planning Commission denial and the City Council hereby desires to grant said appeal and approve said Amendment; and

WHEREAS, the permit was set for a public hearing to be conducted by the Council of The City of San Diego; and

WHEREAS, the issue was heard by the Council on March 30, 1993; and


WHEREAS, the Council of The City of San Diego considered the issues discussed in Negative Declaration No. 92-0315; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it is hereby certified that Negative Declaration

No. 92-0315, on file in the office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code section 21000 et seq.), as amended, and the State guidelines thereto (California Code of Regulations section 15000 et seq.), that the declaration reflects the independent judgment of The City of San Diego as Lead Agency and that the information contained in said report, together with any comments received during the public review process, has been reviewed and considered by this Council in connection with the approval of Conditional Use Permit Amendment No. 92-0315.

BE IT FURTHER RESOLVED, that the Council finds, based upon the Initial Study and any comments received, that there is no substantial evidence that the project will have a significant effect on the environment and therefore the Negative Declaration is hereby approved.
