BE IT RESOLVED, by the Council of The City of San Diego that the bid of LOCATOR SERVICES, INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SECURITY GUARD SERVICE AT THE CENTRAL LIBRARY as may be required for a period of one (1) year beginning April 1, 1993 through March 31, 1994 at a cost of \$7.49 per worker hour, per prices on file in the Purchasing Department, for a total estimated annual cost of \$55,136.00 with terms of Net 30 days with options to renew the contract for four (4) additional one (1) year periods, with price escalations not to exceed 5% of prices in effect at the end of the prior year.

BE IT FURTHER RESOLVED, that in the event the Contractor fails to perform in accordance with specifications, authorizing the Purchasing Agent to terminate the contract and to award to the next low bidder, and to subsequent bidders, if necessary, until a bidder is found who will comply with specifications.
