
BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF SKYLINE COMMUNITY PARK SECURITY LIGHTING.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$17,000.00 from PSD Fund No. 11690 and \$23,000.00 from PSD Fund No. 15000, to CIP No. 29-771.0, SKYLINE COMMUNITY PARK SECURITY LIGHTING; and authorizing the expenditure of \$102,000.00 from CIP No. 29-771.0,

SKYLINE COMMUNITY PARK SECURITY LIGHTING, \$24,000.00 from PSD Fund No. 11700, \$38,000.00 from Skyline Paradise Hills Special Park Fee Fund No. 39089, \$17,000.00 from PSD Fund No. 11690, and \$23,000.00 from PSD Fund No. 15000, for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
