BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF FLASHING BEACON AND SIGNAL MODIFICATIONS AT BLACK MOUNTAIN ROAD AND PARK VILLAGE ROAD/ADOLPHIA STREET.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to add to the FY93 Capital

Improvement Program CIP 63-016.0, BLACK MOUNTAIN ROAD AND PARK VILLAGE ROAD, INTERSECTION IMPROVEMENTS, as approved in the Penasquitos East Public Facilities Financing Plan.

BE IT FURTHER RESOLVED, that the expenditure of \$80,600.00 from CIP 63-016.0 PEDESTRIAN BRIDGE - BLACK MOUNTAIN ROAD, is hereby authorized solely and exclusively for providing funds for said project and related costs.
