BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with SANDAG (acting as the San Diego County Regional Transportation Agency), for its proportionate participation in the Multiple Species Conservation Program (MSCP), by the contribution of \$150,000, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-281726-2.

BE IT FURTHER RESOLVED, that the receipt of funds under the provisions of these agreements and the deposit of said funds into Clean Water Program Sewer Fund 41509, are hereby authorized.
