RESOLUTION OF THE CITY OF SAN DIEGO APPROVING THE APPLICATION FOR FUNDS FOR THE TRANSPORTATION ENHANCEMENT ACTIVITIES PROGRAM UNDER THE INTERMODAL SURFACE TRANSPORTATION EFFICIENCY ACT OF 1991.

WHEREAS, the United States Congress has enacted the Intermodal Surface Transportation Efficiency Act of 1991, which is intended to provide over \$200 million in federal dollars over a six year period as matching funds to local, state and federal agencies and non-profit entities for transportation enhancement activities; and

WHEREAS, said procedures and criteria established by the California Department of Transportation resolution certifying the approval of application by the applicant's governing body before submission of said application to the California Transportation Commission and the State of California; and

WHEREAS, the application contains assurances that the applicant must comply with; and

WHEREAS, the applicant, if selected, will enter into an agreement with the State of California to carry out the transportation enhancement activities project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the filing of an application for the Transportation Enhancement Activities Program for consideration for the funding of the projects as generally described in Attachment A, "Narrative Description of Proposed ISTEA Projects," is hereby approved.

- 2. That said applicant(s) will make adequate provisions for operation and maintenance of the projects as generally described in Attachment A.
- 3. That the City Manager of The City of San Diego, or his designee, is hereby authorized to conduct all negotiations, execute and submit all documents, including but not limited to application, agreements, amendments, payment requests and so on, which may be necessary for the completion of the aforementioned project.
