BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to execute, for and on behalf of the City, a second amendment to the agreement of May 30, 1989 with Dudek & Associates, Inc. for engineering design services required for replacement of Sewer Pump Station No. 5, under the terms and conditions set forth in the Second Amendment on file in the office of the City Clerk as Document No. RR-281735, as well as any reasonably necessary modifications or amendments thereto which do not increase this project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$19,977, consisting of \$18,437 for Phase II final design and \$1,540 for additional services, from CIP No. 46-106.0, Sewer Revenue Fund No. 41506, is hereby authorized, solely and exclusively to provide funds for the above project.
