BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for TRAFFIC SIGNAL AT CALLE CRISTOBAL AND CAMINO SANTA FE.

BE IT FURTHER RESOLVED, that the expenditure, , not to exceed \$144,900.00 from Fund NO. 79374, Calle cristobal Assessment District, is hereby authorized solely and exclusively for providing funds for said project and related costs.
