
RESOLUTION NUMBER R- 281770

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of a grant deed of MIRAMAR RANCH NORTH, a California general partnership, executed in favor of The City of San Diego, bearing dates of December 21, 1992, and December 23, 1992, a copy of which deed is on file in the office of the City Clerk as Document No. RR-281770, granting to said City an easement for public street purposes in portions of Lots 1, 9, 10 and 13 of Map No. 11991, in a portion of Parcel 1 of Parcel Map No. 11571, and in a portion of Parcel 2 of Parcel Map No. 11428, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SCRIPPS RANCH BOULEVARD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
