WHEREAS, Sharp Rees-Stealy Medical Centers switched its fleet of five service vehicles from gasoline to clean burning natural gas, reducing carbon monoxide emissions up to 90%, reactive hydrocarbons up to 50%, and nitrogen oxides up to 33%; and
