BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$241,711.67 (\$218,855.00, terms net 30 days, plus sales tax, and a contingency cost amount not to exceed \$5471.38, or 2.5% of apparatus cost, plus sales tax) from CIP 330760, Fire Station #43 - Otay Mesa, FUND 39062, Otay Mesa - Fac. Dev. Fund, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


