WHEREAS, Lego Systems, Inc. has been instrumental in laying the foundations for future engineers, architects and builders, continually expanding and challenging youth world wide; and

WHEREAS, Lego Systems, Inc. is currently considering a site in Carlsbad to build a Lego family oriented park which would be Lego's first in the United States; and

WHEREAS, Lego's Family Park would be a welcome addition to the tourism industry in San Diego, already home to the internationally famous San Diego Zoo and Sea World Marine Park; and

WHEREAS, Lego's Family Park would add to the allure of Southern California as a family vacation destination, already home to Disneyland, Magic Mountain, Universal Studios, and Knott's Berry Farm, making it an ideal location for a family oriented Lego Park; and
