RESOLUTION NUMBER R- **281811**

ADOPTED ON APR 26 1993

WHEREAS, in April 1992, The City of San Diego Commission for Arts and Culture submitted an application for a National Endowment for the Arts ("NEA") Local Programs Planning and Administrative Grant in the amount of thirty thousand dollars (\$30,000); and

WHEREAS, The City of San Diego was notified on January 7, 1993, by the NEA that it had been awarded the grant in the amount requested to support the City of San Diego Commission for Arts and Culture's Community Cultural Planning Project; and

WHEREAS, the goal of the Community Cultural Planning Project is to develop strategies and an action plan to achieve cultural equity and diversity in the City's Arts and Culture Program accessible to all communities; and

WHEREAS, the special role that the City plays as the lead agency shaping the cultural landscape of this border town, home of many established and recently arrived ethnic groups, requires that it become intimate with the needs of both the community at large and the artistic and cultural community;

WHEREAS, the NEA conditions acceptance of the grant upon the City's providing matching funds in the amount of thirty thousand dollars (\$30,000); and

WHEREAS, twenty-two thousand seven hundred fifty dollars (\$22,750) of matching money is available in the 1993 Art and Culture Commission's Program Budget Fund No. 10224; and


WHEREAS, the City's current grant from the California Arts Council's State Local Partnership Program (California Arts Council) is eligible to be used for matching the grant from NEA; and,

WHEREAS, seven hundred two hundred fifty dollars (\$7,250) in California Arts Council grant monies is available in Fund No. 19007 to match the NEA grant; NOW, THEREFORE,

BE IT RESOLVED, that the City of San Diego accepts the terms and conditions of the NEA Local Programs Planning and Administrative Grant in the amount of thirty thousand dollars (\$30,000) to support the City of San Diego Commission for Arts and Cultures's Community Cultural Planning Project.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the thirty thousand dollars (\$30,000) in matching monies be paid out of the following funds: Twenty two thousand seven hundred fifty dollars (\$22,750) out of Fund No. 10224; and, seven thousand two hundred fifty dollars (\$7,250) out of Fund No. 19007.


