BE IT RESOLVED, by the Council of The City of San Diego, that Contract No. 1, Change Order No. 1, dated September 23, 1992 and heretofore filed with the City Clerk of said City as Document No. RR 281823, issued in connection with the contract between The City of San Diego and Western Summit Constructors, Inc., said contract having been filed in the office of the City Clerk as Document No. RR-277392 / RR-279432, be and the same is hereby approved, together with the changes therein set forth, amounting to a net increase in the contract price of \$188,482.00.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$188,482.00, consisting of \$94,241.00 from Water Revenue Fund 41500, CIP No. 73-290.0, San Pasqual Water Reclamation Facility, and \$94,241.00 from Sewer Revenue Fund 41506, CIP No. 46-151.0, San Pasqual Water Reclamation Facility, is hereby authorized, solely and exclusively for the purpose of funding this change order.


