BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer an amount not to exceed \$41,500 from the Rancho Penasquitos East FBA Account No. 79-004 to CIP No. 52-415.0, Park and Ride--Carmel Mountain Road and Penasquitos Boulevard.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to expend the amount of \$41,500 from CIP No. 52-415.0 by the issuance of Warrant Check

No. 2197860 in the amount of \$41,500, made payable to American Newland Associates.
