

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to establish Capital Outlay Grant Fund No. 38521, "G Street/State Route 94 HOV Lane."

BE IT FURTHER RESOLVED, that the FY 1993 Capital
Improvements Program is hereby modified by adding \$707,000 to CIP
No. 52-562.0, G Street/State Route 94 HOV Lane.
