ADOPTED ON APR 26 1993

WHEREAS, Cesar Chavez dedicated his life for the betterment of the living conditions of the farm workers; and

WHEREAS, Cesar Chavez fasted to stop the degradation of the farm workers by organizing a national grape boycott to stop the use of dangerous pesticides; and

WHEREAS, Cesar Chavez gave his life so that the life of the farm workers could be a little better by trying to raise the wages of the workers; and

WHEREAS, Cesar Chavez' cause was finally recognized by the United States government and was visited by Robert Kennedy who called him "One of the heroic figures of our time" at the fasting site in the middle of a field; and

WHEREAS, Cesar Chavez founded the United Farm Workers Union, AFL-CIO, to protect the human rights of farm workers; and

WHEREAS, Cesar Chavez will be remembered as a great humanitarian for his contribution to the humane treatment of farm workers; and

WHEREAS, Cesar Chavez will be remembered as the personification of farm workers and the labor movement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, hereby adjourns in memory of CESAR CHAVEZ, this day April 26,


