BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF FIRE STATIONS 28, 36 & 38 BATHROOM ADDITIONS, San Diego, California, on file in the Office of the City Clerk of San Diego, California on MAY 03 1993, and bearing official document No. W.O. 112025, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF FIRE STATIONS 28, 36 & 38 BATHROOM ADDITIONS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$282,924.00, from CIP 330780, Annual Allocation - Bathroom Additions to Fire Stations, Fund 302453, Capital Outlay - Other, for engineering and related work for renovation of 18 stations to

add restrooms for female staff, and that the expenditure, not to exceed \$87,405.00 from CIP 330780, Annual Allocation - Bathroom Additions to Fire Stations, Fund 302453, Capital Outlay - Other, for the purpose of executing this contract and for the related costs incurred, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
