BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$98,000, consisting of \$29,030 from Sewer Revenue Fund 41506, CIP No. 46-117.0, Pump Station No. 65 Expansion and Force Main; \$29,030 from Sewer Revenue Fund 41506, CIP 46-122.0, Carmel Valley Trunk Sewer Replacement; and \$40,000 from Water

Revenue Fund 41502, CIP No. 70-910.1, Sorrento Valley Water Main Relocation, is hereby authorized, solely and exclusively for the purpose of providing funds for the above amendment.
