BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to issue one check in the amount of \$90,000.00, made payable to Valley Sport, Inc and its Attorney of Record: Haasis, Pope & Correll, in full settlement of the lawsuit and of all claims.
