BE IT RESOLVED, by the Council of The City of San Diego that the bids of 1. BELL INDUSTRIES, INC., 2. MOMENTUM GRAPHICS and 3. MOTTA LITHOGRAPHIC SUPPLY CO., are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISC. PRINT SHOP SUPPLIES as may be required for a period of one (1) year beginning Nov. 1, 1992 through Oct. 3, 1993 per prices on file in the Purchasing Department as follows:

1. BELL INDUSTRIES, INC., for Sections I, II - B and D through J, III - A through E, F Item 1 only, and G and H, with terms of 2% 10th, Net EOM, with options to renew the contract for four (4) additional one (1) year periods, with option year prices not to exceed the prices in effect for the previous contract period by more than 5%.
2. MOMENTUM GRAPHICS, for Sections II - A AND C, III - D, AND F, Item 2 only, with terms of Net 30, with options to renew the contract for four (4) additional one (1) year periods, with option year prices not to exceed the prices in effect for the previous contract period by more than 10%.
3. MOTTA LITHOGRAPHIC SUPPLY CO., for Section IV, with terms of Net 30, with options to renew the contract for four (4) additional one (1) year periods, with the prices for the first option year not to exceed those in effect for the first contract year by more than 7.5%, and the prices in effect for the remaining option years not to exceed the prices in effect for the previous contract period by more than 5%.
