RESOLUTION NUMBER R- 281924

ADOPTED ON MAY 17 1993

WHEREAS, Council Policy 300-8 provides for a procedure for the confirmation of the appointment of the Chief of Police; and

WHEREAS, such procedure requires two (2) separate hearings, one of the Council Committee of the Whole and the other of the whole City Council; and

WHEREAS, the current Chief of Police officially retired from City service in January of 1993; and

WHEREAS, Municipal Code section 24.1000 authorized the Chief of Police to be employed for an additional ninety (90) days in this fiscal year; and


WHEREAS, the City Manager utilized a select panel of community leaders to screen fifty-two (52) applications for the position of Chief of Police; and

WHEREAS, where a separate panel interviewed the eight (8) finalists for the position of Chief of Police; and

WHEREAS, it is in the best interest of the City of San Diego to immediately confirm the City Manager's appointment of the Chief of Police; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that the Mayor and the City Council hereby waive the procedures
set forth in Council Policy 300-8.
