BE IT RESOLVED, by the Council of The City of San Diego that the low bid of BARNES COMMUNICATIONS is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing MOBILE PUBLIC ADDRESS SYSTEMS WITH ELECTRONIC SIRENS as may be required for a period of one (1) year beginning June 1, 1993 through May 31, 1994 per prices on file in the Purchasing Department, for a total estimated annual cost of \$28,722.00 with terms of 1% 20 days, plus sales tax, with options to renew the contract for three (3) additional one (1) year periods, with option period price increases not to exceed 5% of the prices in effect at the end of the prior year.

BE IT FURTHER RESOLVED, that in the event the vendor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to the specifications.
