ADOPTED ON MAY 17 1993

BE IT RESOLVED, by the Council of The City of San Diego that the bids of 1. STANDARD PLUMBING AND INDUSTRIAL SUPPLY, 2. WESTBURNE SUPPLY CO., 3. FAMILIAN PIPE AND SUPPLY, 4. VALLEY INDUSTRIAL SPECIALTIES, INC. and 5. RELIABLE PIPE SUPPLY are hereby accepted and the City Manager is hereby authorized to execute contracts for WILL-CALL SERVICE FOR THE PURCHASE OF PLUMBING SUPPLIES as may be required for a period of one (1) year beginning May 1, 1993 through April 30, 1994, as follows:

1. STANDARD PLUMBING AND INDUSTRIAL SUPPLY, Prime Contractor for the following manufacturers: Crane, Eljer, Elkay, Kohler, Moen, Norris, Pasco, Ruud, Sloan, A.O. Smith, Symons, Watts, and Wilkings; terms 2% 20 days, plus sales tax.
2. WESTBURNE SUPPLY CO., Prime Contractor for the following manufacturers: Acorn, American Standard, Bell & Gosset, Bradley, Delta, Eastman, Hammond, Moen, Norris, Pasco, Powers, and Watts; terms 2% 20 days, plus sales tax, with options to renew for four (4) additional one (1) year periods with prices not to exceed 6% of prices in effect at the end of each prior year.
3. FAMILIAN PIPE AND SUPPLY, Prime Contractor for the following manufacturers: ABS Fittings, Haws, Kohler, J. R. Smith, Symons, and Zurn; terms 2% 25 days, plus sales tax, with options to renew for four (4) additional one (1) year periods

with prices not to exceed 5% of prices in effect at the end of each prior year.

4. VALLEY INDUSTRIAL SPECIALTIES, INC., Prime Contractor for Sexauer; terms net 30 days, plus sales tax, with options to renew for four (4) additional one (1) year periods with prices not to exceed 8% of prices in effect at the end of each prior year.
5. RELIABLE PIPE SUPPLY, Prime Contractor for Nibco; terms net 30 days, plus sales tax, with options to renew for four (4) additional one (1) year periods, with prices not to exceed 10% of prices in effect at the end of each prior year.
