BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of easement deeds of SORRENTO VALLEY EAST, LTD., a California limited partnership, executed in favor of The City of San Diego, bearing date of October 31, 1989, copies of which deeds are on file in the office of the City Clerk as Document Nos. RR- 281948-1, RR- 281948-2 and RR- 281948-3, granting to said City easements for public street purposes and for slope and drainage purposes in portions of Parcel 1 and Parcel 3 of Parcel Map No. 14873, as more particularly described in the deeds, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for public streets, and the same are hereby named EL CAMINO REAL and ARROYO SORRENTO ROAD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder at no fee for the benefit of the City, with no documentary tax due.
