- 1. That that certain real property right described in that quitclaim deed on file in the office of the City Clerk as Document No. RR- 281953, be, and the same is hereby determined to be surplus and is hereby authorized to be sold by negotiation for the processing fee to CLEMENT J. O'NEILL.
- 2. That the City Manager or his designee is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR- $\frac{281953}{}$, quitclaiming to CLEMENT J. O'NEILL that certain easement, as more particularly described in the quitclaim deed.
- 3. That no broker's commission shall be paid by the City on the herein described negotiated sale.
- 4. That the City Clerk is hereby authorized to cause the quitclaim deed and a certified copy of this resolution to be recorded in the office of the County Recorder.
