RESOLUTION NUMBER R- 281955

ADOPTED ON MAY 17 1993

RESOLUTION ADOPTING A CONFLICT
OF INTEREST CODE FOR MID-CITY
DEVELOPMENT CORPORATION.

WHEREAS, the Political Reform Act, Government Code section 81000, et seq., requires state and local government agencies to adopt and promulgate conflict of interest codes; and

WHEREAS, local agencies include not only City departments, but also City-owned Corporations, certain City board's and commissions, and certain other local agencies for whom the City Council serves as code reviewing body; and

WHEREAS, on June 8, 1992, by Resolution No. R-280096, the City Council of The City of San Diego established City Heights Development Corporation, a public non-profit Corporation of which the sole member is the City; and

WHEREAS, on October 27, 1992, by Resolution No. R-280971, the City Council changed the name of City Heights Development Corporation to the Mid-City Development Corporation ("Corporation"); and

WHEREAS, the Fair Political Practices Commission ("FPPC") has adopted a regulation, 2 Cal. Code of Regulations section 18730, which contains the terms of a standard conflict of interest code; and

WHEREAS, this standard code can be incorporated by reference and may be amended by the FPPC after public notice and hearings to conform to amendments in the Political Reform Act; and

WHEREAS, a Conflict of Interest Code has been prepared for the Corporation which contains the standard Code, and sets forth the designated positions required to disclose economic interests and the disclosure categories; and

WHEREAS, the President of the Corporation has certified that the Board of Directors of the Corporation adopted this Conflict of Interest Code after the public and members of the Board were given an opportunity to review and comment on the proposed Code; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the Conflict of Interest Code of the Mid-City Development Corporation, including Appendix A (designating employees and setting forth disclosure categories) and Appendix B (showing the geographic boundaries of the Corporation), is hereby approved. A copy of the Conflict of Interest Code, including Appendices, is attached hereto and on file in the office of the City Clerk as Document No. RR- 281955 .

BE IT FURTHER RESOLVED, that pursuant to section (b)(4) of the Conflict of Interest Code, designated persons shall file their Statements of Economic Interest ("SEI's") with the office of the City Clerk.

BE IT FURTHER RESOLVED, that adoption of this Conflict of Interest Code is also intended to serve as compliance with Government Code section 87306.5, which requires biennial review of local agencies' conflict of interest codes.

BE IT FURTHER RESOLVED, that this Conflict of Interest Code shall become effective upon the date of adoption of this resolution.
