WHEREAS, Archie "The Mongoose" Moore was elected to the Boxing Hall of Fame in 1966; and

WHEREAS, Archie Moore has selflessly dedicated his time to helping youth at risk and was named "Mr. San Diego" by the Grant Club in 1968 for his efforts in fighting juvenile delinquency; and

WHEREAS, Archie Moore has been a crucial factor in the success of the Bates Street Boxing Club, giving the youth the benefit of both his boxing expertise and his valuable lessons about honor, citizenship and self-esteem; NOW, THEREFORE,
