appointed and designated as the Management Team for purposes of meeting and conferring with recognized employee organizations:

BE IT FURTHER RESOLVED, that the Personnel Director and Retirement Administrator be and are hereby appointed to and designated as members of the Management Team, pursuant to the above-cited provisions of law and Council Policy, for all purposes except meeting and conferring with employee organizations.
