RESOLUTION OF THE CITY OF SAN DIEGO ADOPTING  
THE SEVEN YEAR TRANSNET LOCAL STREET AND ROAD  
PROGRAM OF PROJECTS FOR FISCAL YEARS 1994  
THROUGH 2001 AND AMENDING THE FISCAL YEAR  
1993 TRANSNET LOCAL STREET AND ROAD PROGRAM  
OF PROJECTS.

WHEREAS, on November 3, 1987, the voters of San Diego county approved the San Diego Transportation Improvement Program Ordinance and Expenditure Plan; and

WHEREAS, the Ordinance provides that the San Diego Association of Governments (SANDAG) Commission shall annually approve a program of projects submitted by local jurisdictions identifying those transportation projects eligible to use transportation sales tax (TransNet) funds; and

WHEREAS, The City of San Diego was provided with an estimate of annual TransNet local street and road revenues for fiscal years 1994 through 2001; and

WHEREAS, The City of San Diego wished to amend the Fiscal Year 1993 list of City projects contained within the 1992 through 1999 TransNet Program of Projects to reflect the final Fiscal Year 1993 City of San Diego budget; and

WHEREAS, on MAY 17 1993 The City of San Diego held a public hearing in accordance with Section 5(A) of the TransNet Ordinance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego does hereby adopt the attached seven-year program of projects to be funded in part with local street and road TransNet revenues for inclusion in the 1994 through 2001 TransNet Program of Projects.

BE IT FURTHER RESOLVED, that The City of San Diego does hereby amend Fiscal Year 1993 list of City projects contained within the 1992 through 1999 TransNet Program of Projects.


BE IT FURTHER RESOLVED, that pursuant to Section 8 of the TransNet Ordinance, The City of San Diego certifies that the required minimum annual level of local discretionary funds to be expended for street and road purposes will be met throughout the seven-year period consistent with Maintenance of Effort Requirements adopted by the SANDAG Commission on June 24, 1988.

BE IT FURTHER RESOLVED, that pursuant to Section 9 of the TransNet Ordinance, The City of San Diego certifies that TransNet funds programmed in the attached Seven-Year Program of Projects do not replace private developer funding which has been or will be committed for any project.

BE IT FURTHER RESOLVED, that pursuant to Section 16 of the TransNet Ordinance, The City of San Diego certifies that each project of \$250,000 or more will be clearly designated during construction with TransNet project funding identification signs.

BE IT FURTHER RESOLVED, that The City of San Diego does hereby certify all other applicable provisions of the TransNet Ordinance have been met.
