RESOLUTION NUMBER R- 281998  
ADOPTED ON MAY 18 1993

WHEREAS, May 18, 1993, has been declared "Regulatory Relief Day"; and

WHEREAS, one purpose of Regulatory Relief Day is to streamline and consolidate, where appropriate, land use and environmental regulatory procedures; and,

WHEREAS, the Building Inspection Department has reviewed Title 24 of the California Code of Regulations, Parts 1-6 and 9 ("Title 24") that pertain to the Uniform Building Code, Uniform Fire Code, Uniform Mechanical Code, Uniform Plumbing Code, Uniform National Electrical Code and Uniform Energy Code ("Uniform Codes"); and

WHEREAS, the Building Inspection Department has found that unnecessary regulations have been added to the Uniform Codes by many of the provisions of Title 24; and

WHEREAS, the Building Inspection Department has suggested that amendments be made to Title 24 to eliminate unnecessary additional regulations to the Uniform Codes in order to streamline the building permit process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be directed to prepare proposed legislation and seek a legislative sponsor to repeal certain State amendments

to Title 24 of the California Code of Regulations Parts 1-6 and 9  
that would not be inconsistent with federal law or jeopardize  
public safety.
