WHEREAS, May 18, 1993, has been declared "Regulatory Relief Day"; and

WHEREAS, one purpose of Regulatory Relief Day is to streamline and consolidate, where appropriate, land use and environmental regulatory procedures; and

WHEREAS, the Fire Department has reviewed Title 19 of the California Code of Regulations, Article 4, Section 904 ("Section 904"); and

WHEREAS, the Fire Department has found that regulations regarding five (5) year certification of automatic fire extinguishing systems in all buildings should be amended; and

WHEREAS, the Fire Department has suggested that amendments be made to Section 904 to amend the five (5) year certification requirement as it related to vacant buildings; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to prepare proposed

legislation and seek a legislative sponsor to amend California Code of Regulations, Title 19, Article 4, Section 904 as recommended by the Fire Chief.
