BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF DESERT VIEW DRIVE SHEAR PIN INSTALLATION.

BE IT FURTHER RESOLVED, that the modification of the FY 93 Capital Improvements Program by adding CIP No. 52-566.0, Desert View Drive Shear Pin Installation is hereby authorized.

BE IT FURTHER RESOLVED, that the City Auditor and

Comptroller is hereby authorized to transfer \$550,000.00 from Fund No. 30300 "TransNet-Proposition A" to CIP 52-566.0.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$550,000.00 from CIP No. 52-566.0, Transnet Fund 30300, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


