WHEREAS, the City Treasurer has received such an affidavit of loss/letter of indemnification in connection with 1911 Act Improvement Bond Series 3570, Bond Number 5, dated 6/1/81; and

WHEREAS, the City Council must authorize the replacement or payment of such a lost bond coupon; and

WHEREAS, the City Treasurer recommends payment in lieu of issuing a replacement bond coupon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the payment in lieu of replacement of the lost bond coupon for 1911 Act Improvement Bond Series 3570, Bond Number 5, dated 6/1/81, be and is hereby authorized.
