WHEREAS, the City is implementing a public art program by allocating funds for the establishment of art in public places, pursuant to San Diego Municipal Code sections 26.0701 et seq; and

WHEREAS, in 1988 the City Gates Program was established as part of the public art program to strengthen San Diego's cultural identity and enrich the collective urban experience through neighborhood art; and

WHEREAS, an international competition was conducted, and in December 1989, the Commission for Arts and Culture approved the recommendation of the artist selection jury to contract with ROBIN BRAILSFORD, YSELA CHACON, and ROBERTO SALAS to fabricate and install "Los Portales de Chicano Park" (the "Project") as part of the City Gates Program; and

WHEREAS, \$150,000 was available in the Public Art Fund in 1988 to complete this Project; and

WHEREAS, in 1989, these funds were reallocated to other City projects; and

WHEREAS, the reallocation of funds necessitated raising funds from other private and public sources in support of the City Gates projects; and

WHEREAS, in March 1990, the City accepted a grant for \$20,000 from the National Endowment for the Arts ("NEA") to construct this Project, which grant required matching funds as a condition of acceptance; and

WHEREAS, the City committed matching monies in the amount of \$20,000 from the Public Art Fund to construct this Project; and

WHEREAS, additional fund-raising efforts over the next few years were unsuccessful; and

WHEREAS, the City Manager recommends contracting with the above-named artists to fabricate and install only one of the four "portales" ("El Portal de la Historia"), which will be located on the pedestrian bridge from Chicano Park to Kearny Street on the northbound onramp from Interstate 5 to the Coronado Bridge; and

WHEREAS, the City Manager states that completing this portal will achieve many of the original goals of the project, which include establishing dialogue between artists and community members resulting in the conceptual, physical and aesthetic linking of the Logan Heights community and community workshops conducted by the artists; and

WHEREAS, of the four "portales," "El Portal de la Historia" is the only portal that does not require expensive scaffolding or freeway closures; and

WHEREAS, the entire portal can be completed without any effect on the freeway or overpass traffic; and

WHEREAS, the California State Department of Transportation ("CALTRANS") has been a co-sponsor in this Project from its inception and is contributing services in support of the installation of the Project; and

WHEREAS, CALTRANS has approved the proposed contract between the City and the three artists through its District Director; NOW, THEREFORE,

BE IT RESOLVED, that the City Manager be and is hereby authorized to execute the Agreement with ROBIN BRAILSFORD, YSELA CHACON and ROBERTO SALAS and CALTRANS on the terms and conditions set forth in the Agreement on file with the Office of the City Clerk as Document No. RR- 282034.

BE IT FURTHER RESOLVED, that the Auditor is hereby authorized and directed to expend an amount not to exceed forty thousand dollars (\$40,000), of which twenty thousand dollars (\$20,000) is available from an NEA grant, for the above-described Agreement.
