BE IT RESOLVED, by the Council of The City of San Diego that the specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF UNIVERSITY AVENUE/LINCOLN AVENUE TWO-WAY COUPLET SYSTEM, on file in the office of the City Clerk of San Diego, California on JUN 01 1993, and bearing official Document No. W.D. 119688, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and she is hereby authorized and directed to proceed to publish in accordance with the law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF UNIVERSITY AVENUE/LINCOLN AVENUE TWO-WAY COUPLET SYSTEM.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$124,000.00 from CIP 11-260.0, TransNet Fund 30300, OHIO STREET DRAIN - UNIVERSITY AVENUE TO LINCOLN AVENUE, to CIP 52-462.0, UNIVERSITY

AVENUE/LINCOLN AVENUE TWO-WAY COUPLET SYSTEM; and authorizing the transfer of \$392,000.00 from CIP 52-504.0, Gas Tax Fund 302191, UNIVERSITY AVENUE - BANCROFT TO BOUNDARY, to CIP 52-462.0, UNIVERSITY AVENUE/LINCOLN AVENUE TWO-WAY COUPLET SYSTEM; authorizing the expenditure of \$3,645,300.00 from CIP 52-462.0, UNIVERSITY AVENUE/LINCOLN AVENUE TWO-WAY COUPLET SYSTEM (\$2,713,300.00 TransNet Fund 30300, \$392,000.00 Gas Tax Fund 302191, and \$540,000.00 State/Local Partnership Fund), for the purpose of executing this contract and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
