RESOLUTION NUMBER R-282055

ADOPTED ON JUNE 1, 1993

WHEREAS, during the Fiscal Year 1992 budget hearings, City Council directed the City Manager's office to commission an independent audit of the San Diego Data Processing Corporation ("SDDPC"); and

WHEREAS, a standard Request for Proposal ("RFP") was issued and based on an evaluation of the responses received, the Warner Group was selected to conduct the audit; and

WHEREAS, the findings of the Warner Group, developed primarily during the period from December 1991 through May 1992, were distributed to the Mayor and City Council in January 1993; and

WHEREAS, the City Manager and the SDDPC Board of Directors have met during a series of workshops to review the findings and to develop a joint set of recommendations based on the audit results, as well as an action plan for implementing them; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that recommendations 5 and 6 of the City Manager, in response to the Management audit of the SDDPC, as contained in City Manager Report No. 93-156, be and they are hereby accepted.

BE IT FURTHER RESOLVED, that recommendations 1 through 4 of the City Manager, in response to the Management audit of the SDDPC, as contained in City Manager Report No. 93-156, have been continued to July 6, 1993, for further Council consideration.

BE IT FURTHER RESOLVED, that the City Manager and SDDPC are hereby directed to report back to the City Council on a semi-annual basis.
