WHEREAS, Bill became a pioneer in the application of computer technology in business; and

WHEREAS, Bill grew Cipher Data Products from a small private firm into one of San Diego's first publicly traded high technology companies; and

WHEREAS, seven years ago, Bill co-founded the CONNECT Program to link the University of California with the private sector in the growth of high technology and biotechnology; and

WHEREAS, as an engineer, entrepreneur and world citizen, Bill personally forms a vital link between academic research and private application of technology, for the benefit of San Diego's economy and the world's supply of goods and services; and

WHEREAS, as a surviving cancer patient, Bill co-founded the National Association of Cancer Patients and the C.U.R.E. Research Program, and he is a living example of what people can accomplish despite this dreaded disease; and

WHEREAS, San Diego battles to survive in an economy converting from defense to civilian high technology, and Bill

rouses San Diego's legions daily to visions of a new Agincourt;

WHEREAS, Bill has pursued enterprises of great pith and
moment, never allowing doubts to be his traitors, nor fearing to
attempt; and

husband, father, leader, volunteer, entrepreneur, gadfly, all




